Board of Directors Meeting - Minutes June 14, 2017

Board President Tim Beatty called the meeting of the Board of Directors to order at 4:00 p.m. at the St. Clair Fire Station.

Budget Hearing

Tim Beatty called the Budget Hearing to order and called for public comments. There were no public comments and the Budget Hearing was closed.

Approval of Minutes – Board Meeting

The minutes of the 06/14/2017 board meeting were approved as amended. The motion was made by Ron Woodard and seconded by Jamie Wright. The motion passed. (See Motion #1 for the voting record.)

Payment of Bills

The bills were presented for payment. Ron Woodard made a motion to approve payment of the bills; Jamie Wright seconded the motion. The motion passed. (See Motion #2 for the voting record.)

Budget

 It was recommended at last month's board meeting to close the AFG Grant Regional Communications Project Special Fund as the project has been completed. Ron Woodard made a motion to approve closing the fund; Jamie Wright seconded the motion. The motion passed. (See Motion #3 for the voting record.) 2. Chief Baker discussed a change made to the 2017-18 budget regarding transferring \$18,000 from the General Fund to the Seismic Grant Fund. Resolution #2017-02 (Resolution to adopt the budget, make appropriations, impose and categorize the tax) was presented to the Board for approval. Ron Woodard made a motion to approve the changes and to approve the resolution; Jamie Wright seconded the motion. The motion passed. (See Motion #4 for the voting record.)

New Business

Election Results – Local Option Levy Measure

The election results for the local option levy were presented to the Board for approval. Ron Woodard made a motion to approve the results; Jamie Wright seconded the motion. The motion passed. (See Motion #5 for the voting record.)

2. Election Results – Board Member Elections

The election results for the three board member positions were presented to the Board for approval.

Position #3: Alan Lee (2-year term 7/1/2017 through 6/30/2019)
Position #4: Jamie Wright (4-year term 7/1/2017 through 6/30/2021)
Position #5: Danny Curler (4-year term 7/1/2017 through 6/30/2021)

Ron Woodard made a motion to approve the election results; Jamie Wright seconded the motion. The motion passed. (See Motion #6 for the voting record.)

3. Oath of Office for Newly Elected Board Members

It was decided to wait until the July board meeting to administer the Oath of Office to Alan Lee, Jamie Wright, and Danny Curler because Danny Curler was not in attendance at this meeting. It was mentioned that it would need to be the first item of business at the July meeting in order for these three board members to vote on motions, sign checks, etc.

4. New Fire Chief Appointment

Ron Woodard made a motion to appoint Doug Kerr as the new Fire Chief effective July 1, 2017. Jamie Wright seconded the motion. The motion passed. (See Motion #7 for the voting record.)

5. Fire Chief Contract

Doug Kerr presented the Board with his proposed employment contract as Fire Chief. There were three items that the Board request be changed, which were as follows:

The parties entered into an Employment Agreement, effective July 1, 2017 to June 30, 2020 **2018**, which provides for a three-year **one-year** term with automatic one-year extensions annually, if mutually agreed upon between Employee and Employer.

Section 9 – Terms of Agreement:

The term of this agreement shall be for a three (3) one (1) year period beginning on the 1st day of July, 2017 and ending on the 30th day of June, 2020 2018; with automatic one-year extensions annually, if mutually agreed upon by Employee and Employer.

Section 10 – Employee Rights:

The Employee shall serve at the pleasure of the Board of Directors of the District and is an "at will" employee. As an "at will" employee, if the Board wishes to terminate the services of the Employee for other than disciplinary reasons, the Employer shall provide the Employee with at least one-hundred eighty (180) ninety (90) days written notice. Such provision is effective regardless of the term of the agreement. The termination of the Fire Chief's services requires a unanimous vote of the Board of Directors.

Ron Woodard made a motion to approve the contract with the above changes. Jamie Wright seconded the motion. The motion passed. (See Motion #8 for the voting record.)
